- Agendas are published the Thursday before the Tuesday (each week) or Wednesday (2nd and 4th Wednesday's of each month) meeting. There are no meetings scheduled when a 5th week occurs.
 - **Work Sessions** occur each Tuesday except 5th Tuesdays.. These are where presentations are made by staff for discussion. No formal decisions are made at these meetings.
 - **Regular Meetings** occur the 2nd & 4th Wednesday's of each month except November and December which occur on the 1st & 3rd due to holidays. Three minute public comments are taken at noon during these meetings and formal decisions are made by the commissioners. Land Use items occur during these meetings.
